## COMPASS™ – Update



### PILOT PROJECT EVALUATION

As the second phase of the COMPASS™ pilot is projected to end this December, the evaluation process will begin. SafetyNET-Rx will be assisting with the evaluation through a survey of all COMPASS™ pharmacies in January 2016. We anticipate the results will be very positive as we have received great feedback from COMPASS™ pharmacies regarding the usefulness of the tools in the pilot project.

### COMPASS™ STATISTICS

Our statistical reports provide us with strong, numerical evidence of the value of the COMPASS™ program. The data is derived from the inputs provided by our pilot pharmacies. The following are the statistics for incident reporting in the CPhIR (Community Pharmacy Incident Reporting) system from September 2013 (Phase I) until the end of October 2015.

To date there have been **4,313** incidents reported to CPhIR. A breakdown of the incidents include:

- **1,017** incidents with an incorrect dose/frequency
- **867** incidents where the incorrect quantity was dispensed
- **635** incidents that involved an incorrect drug

The majority or **3,542** of these incidents had an outcome of NO ERROR, which means the incidents were intercepted BEFORE they reached the patient.

**729** were no harm incidents, which means the incidents reached the patient but did not cause harm.

There were **42** reported incidents that did result in HARM. Information from ISMP Canada indicated that 41 were MILD harm and 1 was MODERATE harm.

## SHARED LEARNING FROM REPORTED INCIDENTS

The following incident was reported to SCPP with the intention of shared learning:

*An electronic prescription was written by the prescriber as amlodipine 2.5mg daily x 1 week THEN amlodipine 5mg daily x 1 month. The prescription was interpreted to be 7.5mg daily. The “THEN” was interpreted to be an “AND.”*

A key message is that on occasion e-prescriptions may include clarifying or additional information, such as a titration of dose. *It is important to look for any statements at the end of the prescription that may be additional or intended to clarify the intention of the prescriber.*

## Scheduling by Reference

---

SCPP is now able to “schedule by reference,” which means that SCPP has adopted the NAPRA drug schedules. Approval is automatic unless Council chooses not to adopt a NAPRA recommendation. Any exceptions to the NAPRA recommendation will be listed at the end of the [Regulatory bylaws](#).

As a result, SCPP will not be separately publishing a Schedule III listing in the bylaws as we have done in the past. However, we will continue to publish changes to the NAPRA National Drug Schedules in this newsletter and on our website and Facebook Group. If you would like to know which drugs are on NAPRA’s listing, you can either check products by drug name, schedule or glossary directly on the [NAPRA National Drug Schedules website](#). For example, you can type in “Schedule III” for a full listing of drugs that can be found within this schedule.

**Please remember to also review the last page of the Regulatory bylaws for exceptions to the NAPRA listing.**

## Advanced Method Training – Administration by Injection

---

It has been over a month since pharmacists were authorized to administer injections in the pharmacy. Our records indicate 718 pharmacists (or about half of all Saskatchewan pharmacists) have been certified for Advanced Method Training.

There are an additional 97 pharmacists who have taken the training, but who have NOT yet applied for certification with SCPP. According to our bylaws, no pharmacist is authorized to provide Advanced Method services, including the flu injection, without certification from the SCPP office. If you have not applied for your certificate and wish to offer this service, please log onto your profile and complete the application.

### HOW TO APPLY FOR ADVANCED METHOD CERTIFICATION

Begin by logging in to your personal member profile. The new link for the application form will be on the **bottom left-hand side of your profile**. If we don't have record of your completed training, the link to the application form will not appear.

Upon approval of your application, SCPP will issue a certificate by email showing the effective date you may begin administering drugs by Advanced Method.

## Privacy Officer Training Requirement

---

To meet the bylaw requirements of the 2015-2016 permit renewal, CPDP had provided live privacy officer training. CPDP is also now offering **ONLINE privacy officer training**.

Several pharmacy managers had declared on their permit renewal application forms that "online privacy officer training"

for their privacy officer would be completed by December 30, 2015. December can be a busy month for pharmacies, so don't delay – get your privacy officer training completed NOW!

## Duplicate Flu Vaccinations

---

Occasionally an individual will receive a second influenza vaccination. Reports to our office suggest the patient either doesn't remember receiving the first vaccination, or believes he is receiving a different vaccination the second time. For whatever reason, you may have a patient who requests another flu vaccine.

Two scenarios have been reported:

1. A patient arrived at the pharmacy and requested a flu shot. After giving the shot, the pharmacist attempted to process the payment only to discover that another pharmacy had already made a claim.

In this case, the pharmacy that processed the original claim had set an appointment for the patient. In anticipation of the patient's arrival, the claim was processed earlier that day prior to giving the flu shot. However, the patient did not keep this appointment and later decided to go to another pharmacy to request the vaccination.

The shot was administered before the second pharmacy learned billing for this patient's flu shot had already been processed elsewhere. The original pharmacy was contacted and the billing was reversed.

2. In the second situation, the patient arrived at the pharmacy and requested a flu shot. The pharmacist provided the service, but when she attempted to bill the program, she discovered a claim had already been processed for the same individual. When asked, the patient admitted that he had indeed received a flu shot from a different pharmacy earlier.


How could these situations be handled more effectively? Because it is a standard practice to review all available information, we recommend that the pharmacist check the PIP profile **prior** to administering the flu vaccine.

While the forms the patient completes do ask the patient to declare if they have had other vaccinations, the patient may be unable to assist with providing this information. By checking the profile once the patient arrives for their appointment, but before administering the vaccine, these issues can be avoided.

Should you realize that the individual has received their vaccination elsewhere or in fact has received it at more than one location, the Ministry of Health is asking pharmacists to submit the captured claim for the vaccine product to DPEBB so that they can account for the dose.

# Prescription Drug Abuse – Health Canada Prevention Program

One of SCPP's field officers recently spoke to an inspector within The Controlled Substances Program, Compliance and Enforcement, Regions and Programs Branch of Health Canada regarding recent visits to pharmacies in our province. The inspector asked SCPP to remind pharmacists of the following:

- 1) **Emergency Supplies** – within the *Narcotic Control Regulations*, Part G of *The Food and Drugs Regulations* and *The Benzodiazepines and Targeted Substances Regulations* (all attached to *The Controlled Drugs and Substances Act* “CDSA”), provisions exist for pharmacists to obtain emergency supplies of CDSA drugs from another pharmacy or hospital. Proper record keeping of both the purchase and the sale of these supplies is required. When supplying or selling a product to another pharmacy, you must obtain a written order including the name of the pharmacist and pharmacy to which you will be supplying the medication, along with the drug name, strength, amount and date. This ‘purchase’ record must be kept with your other CDSA drug invoices. The ‘sale’ must be recorded with your other sales reportable drugs.
  - 2) **Displays of Medication** – Displays of any kind (including compliance packages, or large quantities of medications in glass containers such as globes) should not contain any controlled substances.
  - 3) **Expired and Non-viable Stock** – Unusable stock should be stored in an area that is secured against pilferage or other types of loss. A complete inventory should be available of each container. This inventory should be verified on a regular basis until such time as the medication is disposed of.
  - 4) **Losses and Thefts** – Under the regulations noted in point #1 above, all losses must be reported to Health Canada within ten days of their discovery. If further investigation reveals a difference in the amount lost, an amendment should be sent to Health Canada. No delay should occur to “finish the investigation.” The involvement of the police in any investigation should also not delay reporting to Health Canada.
  - 5) **Refilling a Narcotic** – As per *The Narcotic Control Regulations*, pharmacists cannot refill a narcotic. Pharmacists may fill a smaller quantity of the total prescribed (i.e. part-fill).
- 
- 6) **Unique Order Number** – Pharmacists are provided with a unique code to order CDSA drugs from their wholesaler. This code is to be kept confidential and not shared with other staff. By ensuring the code is undisclosed, a pharmacist will prevent themselves from being held accountable should someone else in the employ of the pharmacy order drugs and remove them from the pharmacy inventory (i.e. theft).
  - 7) **Security** – All CDSA products should be under the care and control of a pharmacist and adequately secured against loss or theft at all times.
  - 8) **Retention of records** – SCPP is in the process of clarifying records retention. In the interim, we have been advised that all CDSA drug records must be kept for two years from the date of the last fill in chronological order in a separate file. Scanning records is permissible, but the hard copy of the prescription must also be retained. The inspector expressed challenges with the automated transaction reporting process as a staff member is required to assist the inspector to view records within the computer software system.

# The Distinction Between Powers of Attorney, Health Care Directives and Substitute Decision Makers

---

## BACKGROUND

It is important for pharmacists to understand the distinction between powers of attorney and health care directives; particularly in situations where pharmacists must determine who is authorized to make treatment decisions for individuals who are unable to make these decisions themselves.

## WHY THE DISTINCTION MATTERS

- In Saskatchewan:
  - health care decisions of individuals who lack the capacity to make a health care decision respecting a proposed treatment are specifically governed by *The Health Care Directives and Substitute Health Care Decision Makers Act* (Saskatchewan); and
  - powers of attorney are governed by *The Powers of Attorney Act, 2002*.
- Although a power of attorney may provide the attorney with the power to act on the grantor's behalf with respect to property and financial affairs as well as personal affairs, a power of attorney does not give the attorney the power to make health care decisions on behalf of the grantor.

- In addition to granting the power to make health care decisions, health care directives will result in the ability of the substitute decision maker to access certain health care information of the person requiring treatment, to the extent that it is necessary for their decision to be an informed one.
