



Member Emeritus Terms of Reference

The conferring of the "Member Emeritus" status upon retired members is to recognize at least 25 years of continuous affiliation with the Saskatchewan College of Pharmacy Professionals (SCPP) or other regulatory bodies for pharmacists.

Any member on the retired register may be designated as a "Member Emeritus" of the College and may use the designation "Member Emeritus Saskatchewan College of Pharmacy Professionals" or "MESCPP" if:

1. he has been a practicing or non-practicing member continually in good standing with the College or any other regulatory body for pharmacists for at least 25 years;
2. he has not been found guilty of professional misconduct or professional incompetence;
3. his name remains on the retired register; and
4. his name is confirmed by the Awards Committee of the College, or successor committee of the College.

Where a member is ineligible pursuant to section 6(b) of Part E.5, Council may, upon receipt of a written request giving reasons, determine that the member is eligible to be designated as a "Member Emeritus."
