



Honorary Life Member Award Terms of Reference

An Honorary Life Member Award will be presented to recognize a member of the Saskatchewan College of Pharmacy Professionals (SCPP) for outstanding contributions to the profession and/or the Saskatchewan College of Pharmacy Professionals (SCPP) beyond the normal call of professional or voluntary obligations.

An Honorary Life Member Award may be granted in recognition of:

- I. A distinguished record of professional service to the community;
- II. And/or Outstanding contribution to the SCPP;
- III. And/or a distinguished record of service to the SCPP;
- IV. And/or specific achievements that enhanced the profession;
- V. And/or long term service to the profession with a distinguished record.

1. The nominee must have made a special contribution to the SCPP either on a local, provincial or national level.
2. The nominee(s) must be a member(s) in good standing of the SCPP.
3. Nomination papers must be accompanied by a brief description of the individual's contributions consistent with the Terms of Reference.
4. Nominations must be received in the office of the Registrar by January 31.
5. The selection will be approved by SCPP Council following recommendation from the Awards and Honours Committee.
6. When possible, the Honorary Life Member award will be presented in conjunction with the Saskatchewan College of Pharmacy Professionals (SCPP) Annual General Meeting.
7. Practising Honorary Life Members shall have their annual personal membership fees waived.
8. Practising Honorary Life Members shall be responsible for all other conditions of licensure.
9. Practising Honorary Life Members shall have voting and all other privileges of practising members.
10. Non-practising, Associate or Retired members shall have their annual membership fees waived.
11. An Honorary Life Member Award does not necessarily have to be presented in any given year.
